**TO THE WATER USERS ON THE COTTONWOOD CREEK DISTRIBUTION SYSTEM
AND THE HUNTINGTON CREEK DISTRIBUTION SYSTEMS**

The purpose of this letter is to hopefully clear up the confusion that has developed over the past two years concerning distribution assessments on both the Cottonwood Creek Distribution System and the Huntington Creek Distribution System. This confusion was created by this office through a series of errors.


In 2005, this office erroneously concluded that the Emery County Water Conservancy District should be included in the assessments on both Cottonwood Creek and Huntington Creek. Accordingly the assessments were prepared and sent. It became evident that this was an error resulting in an indirect assessment to the water users through the conservancy district. The assessment accounts for the conservancy district have been made inactive.

In 2006, this office erred again in concluding that the 2005 assessment had resulted in an over payment of assessments to the Huntington Creek Distribution System and an under payment of assessments to the Cottonwood Creek Distribution System. To correct this perceived error, this office increased the assessment to the Huntington Creek Distribution System, decreased the assessments to the Cottonwood Creek Distribution System, and transferred \$5500 from Huntington to Cottonwood. Actually, there was no need for a correction. Although they had been paid through the conservancy district, the proper assessment amounts had been paid to both distribution systems.

We apologize for these errors and are attempting this year to make the necessary corrections and clear up the confusion. The \$5500 that was transferred from Huntington to Cottonwood will be transferred back to Huntington. Those on the Huntington System who were assessed too much in 2006 will be given a credit against the 2007 assessment. Those on the Cottonwood System who were under assessed in 2006 will receive an additional assessment to bring the system accounts back into balance. Attached is a spreadsheet showing the 2006 and 2007 assessments and the corrections that will be made to each account.
