The annual meeting of the Blue Mountain Distribution System was called to order at 7:08 p.m. Chairman Max Dalton asked Mark Page, Area Engineer from the Division of Water Rights, to conduct the meeting.

Bill Warmack read the minutes of the 1990 annual meeting. There were no corrections or additions. A motion was made by Clem Washburn and seconded by Joseph Barton to accept the minutes as read.

The financial statement for 1990 was discussed. As of January 1, 1990, there was \$632.75 in the Trust Account. Interest accrued during the year was \$45.43. Therefore, the balance as of December 31, 1990 was \$678.18. There were no receipts or expenditures during 1990. A motion was made by Francis Barton and seconded by Leon Adams, to accept the financial statement. The vote was unanimous.

Mark Page then read a brief report from Max Dalton concerning the water diverted during the 1990 irrigation season. He stated that North Creek, as of June 1, 1990 was running about 1.0 cubic feet per second. This water was diverted for about three weeks. The water never reached town after that, so it was turned back into the Carlisle Ditch. A note of interest, the Camp Jackson Snotel Station as of April 24, 1991, reported 44% of average. It is anticipated that there will be a little more runoff this year due to the moisture we received last fall.

Mark Page suggested setting the budget the same as in 1990, with no assessments to be made, with the provision that if it is needed, it could be assessed. A motion was made by Francis Barton and seconded by Clem Washburn to set the budget at \$400.00. The motion passed unanimously.

A motion was made by Leon Adams to reappoint the same Distribution Committee as in 1990. A second was made by John Johnson. The motion passed. The members of the 1991 Distribution Committee are as follows:
