The annual meeting of the Blue Mountain Distribution System was called to order at 7:10 p.m. Chairman, Max Dalton, asked Mark Page, Area Engineer from the Division of Water Rights, to conduct the meeting.

Rick Wilde read the minutes of the 1988 meeting. There were no corrections or additions. A motion was made by Don Barton and seconded by Clem Washburn, to accept the minutes as read. The motion carried.

The financial statement for 1988 was discussed. As of January 1, 1988, there was \$550.40 in the trust account. Interest accrued during the year was \$35.76, therefore, the balance as of December 31, 1988 was \$586.16. There were no receipts of expenditures during 1988. A motion was made by Max Dalton, and seconded by Joseph Barton, to accept the financial statement. The vote was unanimous.

Mark Page then read a brief report from Max Dalton concerning the water diverted during the 1988 irrigation season. He stated that the Blue Mountain Irrigation Company started water turns on May 1, and stopped on July 1. The current snow pack on the Blue Mountain was felt to be about 50% of normal. Mark Page mentioned that the reason there is not any runoff this year, is due to the dry fall in 1988. All the water is going back into the soil.

Mark Page suggested setting the budget the same as 1987, with no assessments to be made, with the provision that if it is needed, it could be assessed. A motion was made by Francis Barton and seconded by Max Dalton to set the budget at \$400.00. The motion passed unanimously.

A motion was made by Francis Barton to reappoint the same Distribution Committee as in 1988, with the exception of the addition of a Vice Chairman. A second was made by Philip Palmer. The motion passed. The members of the 1989 Distribution Committee are as follows:
