It was moved by Earl Wright and seconded by Maurice Harvey that the minutes of the annual meeting held March 4, 1982, be approved as read. Motion carried.

President Thomas presented copies of the financial reports for 1982, as compiled by the State Engineers Office.

Discussion was made on the Water Uses paying 50% of the Health Program and noted the increase of Retirement and Social Security.

It was moved by Mr. Harvey and seconded by Mr. Wright that the Water Users recommend that the same budget for 1983 be the same as 1982, a total of \$17,875.00. Motion carried.

Commissioner Clayburn reported that three (3) new recorders were purchased and placed in canals. There was ample water in the rivers so that no water was purchased from the Starvation Reservoir. See report of the 1:00 p.m. meeting.

It was moved by Mr. Abbott and seconded by Mr. Lindsay that the Water Users approve the appointment of David K. Clayburn as Water Conditioner. Motion carried.

It was moved by Mr. VanTassell and seconded by Mr. Moon that the Water Users Association request that A.C.P. money or Salinity Money that is set up for use in the Duchesne River also be made available to the Canal Companies. Motion Carried.

It was moved by Mr. Harvey and seconded by Mr. Wright that Earvin Murphy and Jay Abbott be elected Board Members for a three year term. Motion carried.

It was moved by Mr. Murphy and seconded by Mr. Wright that the officers for 1983, be the same as the officers of the previous year. Motion carried. The list of new officers is as follows:
