Pursuant to the Motion of the State Engineer for an Order of Distribution dated April 30, 1981, requesting that the waters of the Duchesne River System be distributed according to the schedule prepared by the State Engineer and for an interim Order of Distribution pending Hearing on the matter, and good cause appearing therefore, it is hereby ORDERED that:

1. The Duchesne River Commissioner is to distribute the waters of said System according to the Distribution Schedule prepared by the State Engineer (attached hereto as Exhibit A) when the flow of water drops to the point that it becomes necessary to place the Duchesne River System on regulation pending further Order of this Court;
2. If any objections are filed to the method of distribution proposed by the State Engineer, the Court will forthwith set the matter for Hearing on such objections; and,
3. This Order is made and entered without prejudice to the claims or assertions of any of the parties in any subsequent proceedings in this action, and does not constitute a final determination by this Court on the rights of the parties or the final duty of water from this source.
