Barnard White reported that Hansen Associates had indicated a willingness to serve as water commissioner for 1985. A motion by Marion Olsen that we recommend Hansen Associates as water commissioner for 1985. Seconded by Jay Bankhead. Motion carried. After study of the financial report, Jay Bankhead made a motion that we recommend an assessment of \$1,000 and use some money that is on hand in the trust fund to make a total budget of \$1405. Seconded by Marion Olsen. Motion passed. Meeting closed at 1:20 p.m.

The financial report was given by Earl M. Staker. Motion by William Obray that we accept the financial report. Seconded by Marion Olsen. Motion passed.

Mr. Staker asked for permission to invest distribution funds so as to earn interest. A motion was made by Marion Olsen to give Mr. Staker this authority. Seconded by Jay Bankhead. Motion passed. ~~Staker~~ Hall

The commissioner's report was given by Craig Hansen. A suggestion was made by Mr. Hansen that we investigate the measuring devices and decide how to fix them so they can be used to get good measurements, as soon as the high water is over this spring. A motion by Jay Bankhead that we follow this suggestion. Seconded by William Obray. Motion passed.

A motion was made by William Obray that we set the budget at \$1375 for engineering fees and \$30 for bonds and insurance. Seconded by Gerald Swenson. Motion passed.

Jay Bankhead made a motion that we employ Hansen and Associates as Water Commissioners for 1985. Seconded by Marion Olsen. Motion passed.

A motion by Jay Bankhead that the officers for the Little Bear River Water Users Association remain the same as last year for 1985. Seconded by William Obray. Motion passed.

A motion was made by William Obray that the directors for the association be the same as for 1984, unless we are notified differently. Seconded by Jay Bankhead. Motion passed.
