

Minutes of the Annual Meeting of the Directors of the Little Bear River Water Users Assoc., held February 10, 1971 at 1:30 p.m. in Hyrum Utah.

Those present were: Barnard White, Ernest Leishman, Marion Olsen, Henry Murray, Allan Poppleton and Chester Farnsworth.

Chairman Barnard White conducted the meeting.

Minutes of last year's meeting were read. Marion Olsen moved, seconded by Henry Murray that the minutes be accepted as read. Passed.

Chester Farnsworth moved, seconded by Allan Poppleton, that we recommend to the Water Users' Assoc. that Keith Hansen be hired for 1971 for the sum of \$1000.00. Passed.

Marion Olsen moved, seconded by Henry Murray that we recommend to the Water Users' Assoc. that we have a budget for 1971 of \$1100.00.

Chairman Barnard White suggested that we recommend to the Water Users Assoc. that some of the water in the Hyrum reservoir be turned loose now so that we can control some of the spring run off to prevent flooding below the dam.. After a discussion of this it was decided to present it to the Board of Directors.

Ernest Leishman moved for adjournment. Passed

Lamont Allan moved that the report of the Commissioner be approved and that he and his staff be commended for the fine job they are doing. Seconded by Marion Olsen. Passed unanimously.

Chester Farnsworth moved, that we recommend to the State Engineer, that we hire Keith Hansen for 1971 at \$1000.00. This motion was seconded by Melvin Archibald and passed unanimously.

Mr. Donald Norseth stated that they would hire Mr. Keith Hansen as the Water Commissioner for Little Bear River Water System for 1971.

Marion Olsen moved that we adopt the same budget as last year, \$1100.00. Motion was seconded by Lamont Allan and passed with unanimous vote.

Mr. Norseth stated that there should be a weire put in the Porcupine Creek.

He also suggested that we all become acquainted with the bill in the State Legislature at the present time called "Recreational Uses of Natural Flowing Streams."

Mr. Chester Farnsworth moved that we recommend to the State Engineer that ~~XX~~ he invest our surplus money. This motion was seconded by Marion Olsen and passed unanimously.


Chairman Barnard White recommended that some of the water in the Hyrum Dam be released now to prevent flooding later.
