

ANNUAL MEETING OF THE DUCHESNE-STRAWBERRY RIVER
WATER USERS AND THE STATE ENGINEER.

PLACE: Duchesne County Court Room, Duchesne, Utah

DATE: March 26, 1970

Meeting was called to order by State Engineer Hubert C. Lambert at 10:00 a.m.

State Engineer stated that he felt that this area could expect a good delivery of water for the 1970 irrigation season. After brief remarks the meeting was turned to the president of Duchesne and Strawberry Water Users Inc., Mr. Ray Thomas.

Minutes were called for and read by Leland Wright. A motion was made by Frank Liddell and seconded by Melvin White that the minutes be accepted as read.

Financial Report

Frank Reese Controller from the State Engineer's office presented a financial report for 1969 irrigation season.

After hearing the report a motion was made by Frank Liddell and seconded by Leo Haueter to accept the financial report as given.

Water Commissioner's Report

Mr. Leo L. Brady, 1969 Water Commissioner for Duchesne and Strawberry Rivers Inc. reported on the 1969 delivery of water. He stated that controlled delivery of water started July 28th and through August. That the average yield for this system was five acre feet per acre.

He also commented on the diversions along the stream, stating that they remained about the same as reported in previous years, regarding measuring devices.

A comment on the budgeted items showed an increase in the Commissioner's travel which was due to the additional travel which may come as a result of the change of stream gaging stations on Strawberry river and Knight Diversion Dam.

The motion was made by Melvin B. White and seconded by Porter L. Merrell that the water users go on record accepting the purposed budget, and instruct the State Engineer's office to assess the water users in the amount of \$8,400.00, and authorize the State Engineer to over expend \$200.00 on any budgeted item, but not to exceed an over all expenditure of \$8,600.00. State Engineer Lambert reported they were pleased with the work done in the past by Mr. Brady, and that he would be appointed for the next year.


