

Logan River Assessment

The assessment is levied on second feet of right as set out in Schedule A and a standard rate. The standard rate is calculated from the total second feet of all rights divided into the budget. Irrigation, stockwatering, and municipal rights are assessed on the basis of their second feet of right times the standard rate. Power rights are assessed on their second feet of right time one-half of the standard rate.

Term of Commissioner

The commissioner's term of duty shall begin April First and extend for one year or until a successor is appointed.

Disbursement of Funds




