MINUTES OF ANNUAL WATER USERS' MEETING
ESCLANATE VALLY-MILFORD AREA

The meeting was called to order by James Mayer at 7:15 p.m.

Minutes of the 1968 meeting were read and approved with no corrections.

Financial report of 1968 was read by John Bene, Deputy State Engineer.

Russel Mayer made a motion to accept financial report as read. Jerry Mayer seconded the motion.

Question was raised as to what was being done about the delinquent accounts.. John Bene told the members present that the accounts had been sent to the Office of the Attorney General.

Commissioner LEE Strong gave his report on water conditions of Beaver County, including the present water level of Minersville Reservoir which is 48½ feet.

Russel Mayer asked the question, who is responsible for cleaning out the Beaver River channel, should water have to be turned down the river. Gerald Stoker said it was the responsibility of those persons who put the ^{OBSTRUCTION} ~~block~~ in the river.

Lloyd Mayer nominated Lee Strong as Water Commissioner for 1969. J.H. Valine Seconded the Motion. The motion carried.

Shirley Nichols made a motion to set up the budget for 1969 the same as last year. Lloyd Mayer seconded this motion, and it carried.

Policies of the State Engineer were read by Gerald Stoker. These policies followed along the same lines as those of 1968.

Motion was made that the same officers remain. Lloyd Mayer seconded. The motion carried.
