SUBJECT: Water Assessments (Accounts 33-161 and 33-162)

Your assessment this year has a credit. We took your legal acres, which is the same amount as the acres used, and used the assessment calculated for that amount for the 1997 and 1998 calculation. We then took the \$82.65 that was paid by both of you last year and divided it in half, and gave each of you \$41.33 credit before your 1997 assessment was deducted. After subtracting your 1997 assessment amount from the \$41.33 each account had a carry over credit for this year. Then deducting this year's (1998) assessment you still have credit. No payment is due for the 1998 assessment year.
