

MINUTES OF THE OGDEN RIVER WATER RIGHTS COMMITTEE, HELD  
JANUARY 11, 1983, WITH THE STATE ENGINEER REPRESENTATIVES  
IN THE WEBER COUNTY COMMISSION CHAMBERS, SEVENTH FLOOR,  
MUNICIPAL BUILDING. OGDEN, UTAH 2:15 PM

Mr. Northseth welcomed everyone and gave a report of the situation of the snow pack and the coming water season. He explained that if the year continued as normal we could expect a good water year. At Ben Lomond Peak water content of snow pack is 170% of normal. In September we experienced heavy rains. The Great Salt Lake is at a very high level.

The secretary read the minutes and they were approved.

The Budget for 1983 was presented by chairman Barker. There was no discussion on the budget.

Commissioner's annual report was read.

It was recommended to the State Engineer that Mr. Boyd Heslop, and Mr. John Wilson be reappointed as Commissioner and Deputy Commissioner. Mr. Northseth accepted this recommendation.

Mr. Burns Wangsgard presented some concerns about creating a pressurized system for Huntsville Irr. Co. By putting their water into pipes, some water would not be needed nor used, and therefore lost. Mr. Wangsgard wanted the recommendation of the State Engineer. Mr. Northseth stated that the direction to go would be to send their proposal to the State Engineer and have him make a ruling.
