TEMPORARY INJUNCTION

Upon notice of David S. Kent, Attorney for George D. McFarland,
Leonard Blanch, Heber Hancock, Pioneer Land & Irrigation Company,
Harold East, Orval Hansen, Harold Gibson, Gibson, Green & Gibson,
S. Miya, Merlin Larkin, Sam Knight, Herbert Heslop, John Heslop,
Clifford Heslop, Tom McFarland, and Suguimoto Martini, some of the
Defendants above named, made in Open Court on June 19, 1963, for an
Injunction enjoining the plaintiffs, Warren Irrigation Company and
Ogden City from diverting waters from the Ogden City sewer outfall into
the Warren Canal and away from the Weber River, and the Court having heard
testimony regarding the fact situation in the above entitled action and
the Court having heard argument of the respective counsel and
the Court being fully advised in the premises,

NOW, THEREFORE, the said Warren Irrigation Company and the said
Ogden City, Plaintiffs above named, are hereby absolutely ENJOINED and
RESTRAINED during the pendency of the above entitled action and until
its final determination, or until the court shall otherwise Order, from
diverting any water from the Ogden City sewer outfall line into the

Warren Irrigation Company Canal and away from the Weber River. This
Injunction is effective immediately.
