Re: Paragraph 97 (Island Ditch) on
Page 64 of the Provo River Decree

The following information concerns the water rights awarded in the Provo Decree for the Island Ditch (copy of page from decree enclosed):

Award (a) for Midway Irrigation Company is covered by Files 55-11506 (1st class) and 55-11507 (17th class) and has been assessed under Account No. 185. along with Midway's other rights. Since Island Ditch Water Company has obtained 254 shares of Midway Irrigation and want to have their portion separately assessed, these awards will be split out to have their own assessment account which will be sent c/o Island Ditch Water Company.

Award (b) is covered by Files 55-11508 (1st class) and 55-11509 (17th class). It was originally for Alfred Alder, and chain of title has been filed to update ownership to Floyd and Lois Bonner. It is being assessed under Account No. 215 to Mr. Bonner which will be updated to be sent to Island Ditch Water Company.

Award (c) is covered by Files 55-11510 and 55-11511 and has been conveyed from Abram Barker to Heber Valley Special Service District.

Award (d) is covered by Files 55-11512 and 55-11513. The files are in the name of William L. Van Wagoner and John Van Wagoner Jr. There are no deeds or other title documents updating ownership of these files, but they are being assessed under Accounts 204 to Harvey Van Wagoner and 216 to Russell Price. These accounts will be updated to be sent to Island Ditch Water Company.

Award (e) is covered by Files 55-11514 and 55-11515. The decree is in the name of William Winterton, but the United States Bureau of Reclamation has filed water user's claims on these rights.

Award (f) is covered by Files 55-11516 and 55-11517. The ownership has been updated from John Murri to Howard and Marilla Bodily, and the rights are assessed under Account 217 which will be sent to Island Ditch Water Company.

Award (g) is covered by Files 55-11518 and 55-11519. Ownership of 25 acres of this award has been updated from Hyrum, T. Fred, and Moroni Winterton to Calvin Probst. Notations on the file indicate a partial chain of title to the remaining 10 acres to Floyd and Lois Bonner. The Probst portion is being assessed under Account 220 and the Bonner portion under Account 215 which will be sent to Island Ditch Water Company.

Award (h) is covered by Files 55-11520 and 55-11521. This was decreed to E. R. Bronson, and no updating title documents are on file. It is being assessed to Calvin Probst under Account 220 and Harvey Van Wagoner under Account 204 which will be addressed to Island Ditch Water Company.

Award (i) is covered by Files 55-11522 and 55-11523. This was decreed to Joseph S. Wright, and title has not been updated. Part of the right is being assessed to Calvin Probst under Account 220 and part to Sharon Winterton under Account 221.

Award (j) is covered by Files 55-11524 and 55-11525. This was decreed to William Bonner, and title has not been updated. It is being assessed to Floyd Bonner under Account 215 which will be sent to Island Ditch Water Company.

Award (k) is covered by Files 55-11526 and 55-11527. This was decreed to James Pyper, and title has not been updated. It is being assessed to Harvey Van Wagoner under Account 204 which will be forwarded to Island Ditch Water Company.

Award (l) is covered by Files 55-11528 and 55-11529. Title has been updated from Henry Zenger to Howard and Marilla Bodily. It is assessed under Account 217 which is to be updated to Island Ditch Water Company.

Award (m) is covered by Files 55-11530 and 55-1531. It was decreed to James Hamilton, William Hamilton, Ella Snyder, Jennie Summers, Lovica Snyder, Mary Chambers, Maggie Campbell, Theodore Hamilton and David Hamilton. There has been no title update or assessment.
