Thank you for your payment for the above captioned distribution system account in the name of Robert L. McGregor, and for letting us know you now own the property once owned by him. We have changed the distribution account showing you as the owner. The water right associated with this account is 55-11183 and indicates Mr. McGregor does own a portion of that right. In order to change his ownership portion of the water right into your name, we will need copies of Warranty Deeds showing the person(s) he purchased the property from, the total amount of his interest in the water right, and one showing transfer of title from him to you. This should be sent to Judy Barbour here in the Division of Water Rights.

The distribution system is regulated by the State Engineer under authority of Section 73-5-1, Utah Code Annotated, 1953, as amended to insure orderly distribution of water based on water rights. A budget is set and assessments are made each year to meet the expenses of the distribution system including the commissioner's salary. The budget and assessments are set by the water users at the annual distribution meeting with the State Engineer. If assessments are not paid by June 1st a delinquent penalty of 10% is added.
