Dear Snyderville Basin Water User:

This letter is your notification that the State Engineer will continue to implement water regulation in the Snyderville Basin during the year 2010.

The following water users participate in the planning and reporting program and are required to submit water use plans to this office each year.

These entities must submit their water use plans to this office prior to diverting water in 2010.
Your 2010 Water Use Plan must be submitted before December 22, 2009.

Guidelines for submitting water use plans are as follows: Enclosed is a copy of your approved 2009 water use plan with only the year changed to 2010. Please review the enclosed plan and make any necessary corrections and return it to this office with a letter stating (1) you are submitting your 2010 use plan that you intend to follow during the 2010 calendar year, (2) any revisions/updates with a short description or explanation (such as changes in water right status or use and/or new facilities, etc.), and (3) the contract numbers and quantities of storage contracts with Weber Basin Water Conservancy District or other important contracts upon which water use or exchange rights are based. The objective of these plans is to show that all of the proposed use is in accordance with valid water rights. Changes to your plan should be approved prior to any deviations from the approved plan, and can be made at any time but are encouraged to be made annually if possible to maintain efficient planning, reviewing, and reporting. This coordinated planning effort is an important part of system operations both inside and outside the Snyderville Basin.

The regulation and periodic reporting of water diversions and total use will continue in 2010 and will be performed by the deputy commissioner under the direction of

the river commissioner and this office. Many of the above-referenced Snyderville entities measure and report their own annual use under the Public Water Supply Water Use Program. The Commissioner is requested to report the annual total water use under the water rights identified in the use plans approved for these Snyderville entities, and report the annual use totals in his annual commissioner report.
