

WEBER RIVER DISTRIBUTION SYSTEM

BASIS OF ASSESSMENT FOR 2002

1. The individual assessment for the distribution of water on the Weber River System is based on the past five-year annual use of water in acre feet. All rights are divided into seven general classes as follows:

Class 1 - Reservoir water, natural flow water used on lands with a decreed duty of 130 acres to the CFS, and measured application water (water that is measured that is from priorities subsequent to 1903).

Class 2 - Natural flow water used on lands with a duty of 100 acres to the CFS.

Class 3 - Natural flow water used on lands with a duty of 80 acres to the CFS.

Class 4 - Natural flow water used on lands with a duty of 75 acres to the CFS.

Class 5 - Power Rights.

Class 6 - Unregulated or unmeasured rights.

Exchange

Class - Water used by individuals who have no other decreed water rights where water is replaced by a storage right.

2. In the Weber River Decree difference in duty and return flow was recognized. This duty of water is reflected in the individual assessment; i.e., the decreed rights serving land with a duty of 130 acres to the CFS is assumed to have consumed all the water delivered. These rights will be assessed the five-year average amount delivered times the determined basic rate. A right having a duty of 100 acres to the CFS is assumed to have consumed  $100/130$  or 76.9% of the water delivered and will be assessed 76.9% of the basic rate times the past five-year average use. A right with a duty of 80 acres to the CFS is assumed to have used  $80/130$  of the water delivered and will be assessed 61.5% of the basic rate times the past five-year average use. A right with a duty of 75 acres to the CFS is assumed to have consumed  $75/130$  of the amount delivered and will be assessed 57.6% of the basic rate times the past five-year average use.

3. Reservoir water, decreed rights serving land with a duty of 130 acres to the CFS, and measured application water will be assessed the five-year average amount times the basic rate.
4. Power rights will be assessed on a acre foot basis averaged over a five-year period. The rate will be 1/7 of the basic rate.
5. Unregulated rights include all rights unmeasured by the Commissioner, most of which are located on the outskirts of the river system. The services of the Commissioner are available to them on call even though because of location and physical condition it is not generally necessary for the Commissioner to make regular visits to these rights. These rights will be assessed on a CFS basis depending upon their priority of use. Such rights will be divided into four sub-classes as follows:

Class A - Priorities up to 1875, inclusive.

Class B - Priorities from 1876 to 1890, inclusive.

Class C - Priorities from 1891 to March 1903, inclusive.

Class D - All rights subsequent to March 1903.

The rates for unregulated rights are increased or decreased in proportion to the basic rate of the past year to the basic rate of the year previous to that. Since last year's basic rate increased 10.5% the basic assessment will be as follows:

Class 6a - \$31.12 per CFS.

Class 6b - \$20.14 per CFS.

Class 6c - \$16.54 per CFS.

Class 6d - \$8.36 per CFS.

6. The total five-year average measured by Classes 1 through 5 after modification by return flow (Paragraph 2), and in the case of the power rights 1/7 of the total acre feet used, divided by the amount to be assessed against such classes will determine the basic rate used to determine the appropriate assessment per acre foot of water delivered.

7. The exchanged class is assessed against the owner of the right and is twice the basic rate or \$10 minimum, whichever is greater.
8. The minimum assessment for any right on the Weber River System will be \$5. The minimum assessment for any measured right will be \$10. The minimum exchange class assessment is \$10.

Therefore, the basic rate is calculated as follows:

Procedure for computing assessments:

- Compute Class 6 rate.
- Add 15% of item 6, State Engineer Surcharge, and Gaging Station charge to Park City Budget.
- Subtract Park City portion of Basic Rate users from adjusted Park City Budget (Park City Budget +15% of Budget item 6 and other add ons)
- Divide balance of previous computation by AF total of approved exchange Park City water to get special exchange rate.
- Compute special exchange charges for Park City.
- From the total Budget figure subtract the amount collected from Class 6 water + all exchange assessments.
- From the above balance compute the Basic Rate.

Basic Rate is  $\frac{\$108,062}{514,820}$  which is \$0.2002 per acre foot.

Class 1 - \$0.2002 per acre foot delivered  
 Class 2 -  $\$0.2002 \times 76.9\%$  is \$0.1540 per acre foot delivered  
 Class 3 -  $\$0.2002 \times 61.5\%$  is \$0.1231 per acre foot delivered  
 Class 4 -  $\$0.2002 \times 57.6\%$  is \$0.1153 per acre foot delivered  
 Class 5 -  $\$0.2002 \times 14.3\%$  is \$0.0286 per acre foot delivered

The assessment for water in the Park City area will be the same rate as the rest of the users for the irrigation rights. The balance of the assessment will be divided and prorated to the exchange users based on the number of acre feet they have rights to under their exchange applications. The exchange rate will be \$0.873 per acre foot or \$10 minimum.
