NOW THEREFORE, if the said Principal shall well, truly and faithfully perform all official duties now required of him by law and also such additional duties as may be imposed on him by any law of the State, subsequently enacted, and if he shall account for and pay over and deliver to the person or officer entitled to receive the same, all moneys or other property that may come into his hands as such officer, then this obligation to be null and void and of no effect; otherwise to be and remain in full force and virtue.

The bond is executed by the Surety upon the express condition that the Surety may, if it shall so elect, cancel this bond by giving twenty (20) days notice in writing to State of Utah

and this bond shall be deemed cancelled at the expiration of said twenty (20) days, the Surety remaining liable for all or any act or acts covered by this bond, which may have been committed by the Principal up to the date of such cancellation; and the Surety shall, thereupon, refund the premium paid, less a pro rata part thereof for the time this bond shall have been in force.
