

MINUTES  
ANNUAL MEETING  
PAROWAN VALLEY WATER USERS

The annual meeting of the Parowan Valley Water Users was held at 7:00 pm in the Iron County Courthouse on February 27, 1980.

The meeting was called to order by Donald C. Norseth, Directing Engineer, who introduced the representatives of the Division of Water Rights.

Mr. Norseth gave a brief overview of the water situation for the 1980 water year. He mentioned that the precipitation was above normal, but that the unseasonably warm weather could cause an early run-off and a long summer.

With this introduction, Chairman Earl Bunn went into the business of the meeting.

The first item of business was the reading of the minutes of the 1979 meeting. The minutes were read by Arthur V. May, Hydrologic Engineer. A motion was made by Clair Halterman to accept the minutes as read. The motion was seconded by Arnold Gurr, and passed unanimously.

Mr. Bunn next asked Mr. Norseth to read the financial statement.

The commissioner's report was given next by Dennis Lowder.

\* The next item of business was the budget for 1980. The budget was set at \$4796.46 which is also the amount to be assessed. The motion was made by Gayle Wood and was seconded by Elmer Gurr. The budget was approved unanimously.

\* Glen Halterman made the motion that Dennis A. Lowder be recommended to the State Engineer for the position of Water Commissioner for 1980. The motion was seconded by Warren A. Dalton and passed unanimously.

981 Jess Pickett was nominated for President of the Pumper Association by Glenn Halterman. The motion was seconded by Lyle Halterman and passed unanimously. The President is to pick a secretary, if he can find someone willing to serve.

Elmer Gurr made a motion that the rules be suspended and Gayle Wood be placed on the Board of the Pumpers Association. Lyle Halterman seconded the motion. The motion passed without dissenting vote.

There was discussion on the latest happenings in regards to Cal. Pac. Power Co.

The meeting was adjourned at 8:10 pm.
