

MINUTES OF THE 1969 MEETING

There was a discussion regarding the selection of a Water Users, Committee, it was mentioned that Cedar City has a five member committee.

A motion was made by Mr. Hal S. Mitchell, and Seconded by Mr. Jess Pickett that the heads of the Irrigation Companies, the President of the Pumpers Organization act as a water users committee. Motion Passed Unam.
