

Nine Mile Distribution System Meeting

Monday, February 3, 1986

Price, Utah

The annual meeting of the Nine Mile Distribution System was called to order by Mr. Kent Jones, Directing Engineer for Distribution at 3:15 p.m. Mr. Jones introduced Earl Staker, Deputy State Engineer and Mark Page, Area Engineer from Price.

Mr. Jones read the minutes of the 1985 annual meeting. There were no additions or corrections to the minutes. Lyle Bryner made a motion that the minutes be accepted as read. Nancy Motte seconded the motion. The motion carried.

The next item of business was the reading of the financial statement. Mr. Jones indicated that as of December 31, 1985, there was a balance in the trust fund of \$1298.02. During the 1985 water year, there was no assessment made and no expenditures against the system. Interest in the amount of \$85.25 was earned from July 1 to December 31, 1985. A motion by Lyle Bryner and seconded by Sharp Bryner was made to accept the financial statement as read. The vote was unanimous.

Some discussion followed concerning the present snow pack. According to the available data, as of January 30, 1986, the Indian Canyon station reported 100% of normal. White River was 118% on the same date. An average year was expected unless precipitation was less than normal during the spring of 1986. During the past few years, water use on the Nine Mile drainage has declined dramatically.

The next item of business was a discussion as to the need for a water commissioner for the 1986 water year. It was decided, by those present, that the system should be operated the same as it had the previous year. Sharp Bryner would work with the upper users. If a problem developed in the lower area of the system, the Price Area Office personnel would offer any assistance needed.

The budget was also to remain the same as it had been for several years. It is as follows:

Lyle Bryner made a motion that the budget be set as defined above. However, there is to be no assessment. If the money is needed it is available. Sharp Bryner was encouraged to turn in any mileage accrued in watching the system in 1986. Nancy Motte seconded the motion. Those in attendance concurred.

With no other business to be discussed, the meeting adjourned at 3:45 p.m.
