MINUTES

THE UPPER SAN PITCH RIVER WATER USERS ANNUAL MEETING

JANUARY 25, 1983, MORONI, UTAH

The meeting convened at 11:00 a.m. and those present were as follows:

The minutes for the 1982 annual meeting were read by Kirk Forbush. Don Norseth gave the snotel report for areas around the state. Precipitaton is very high this year.

Don Norseth read the financial report for 1982 including budget expenditures and delinquent assessments. A motion was made by Joe Bulon and seconded by Reuel Christensen to accept the financial statement as read. The motion carried.

Commissioner Perry Jensen reported on the Upper San Pitch River. Last year was a high water year and the river system ran smooth. Reule Christensen discussed grass removal in the ditches. A particular location of the river, near Milburn, that has overrun due to a diversion was discussed. Stan Adams will set up a time to look at the diversion problem and make recommendations to solve the problem.

The 1983 budget was discussed and assessments were set at \$4,800. A motion was made by Reuel Christensen and seconded by Joe Bulon to accept the budget as set.

Discussion followed on the recommendation of Perry Jensen as commissioner. The motion was unanimous. Don Norseth said he would appoint Perry Jensen as commissioner.

Having only one commissioner for the San Pitch system was discussed. Upper San Pitch Users thought the cost for one commissioner would be greater than for two. Nothing was changed since the joint meeting will not be held until this summer. A summer meeting was set for the first week in May to discuss this subject. It will be held in Ephraim on May 2, 1983.
