

Minutes of a meeting of the Sanpitch water users and representatives of the State Engineer's Office held at the Mt. Pleasant City Hall, Feb. 11, 1954 at 10:30 A.M.

Present from the State Engineer's Office Joseph M. Tracy, Mr. Monson, Mr. Reese and Mr. Porter.

Water users present were according to attached list marked "EXHIBIT A".

The call of the meeting was read by Reuel E. Christensen Temporary Secretary of Sanpitch River water Users.

John E. Jensen, Chairman of Executive Committee conducting.

Mr. Jensen stated that the meeting be opened and conducted according to the call.

Minutes of the annual meeting of 1953 were read and approved.

Mr. Reese from the Engineer's Office presented the annual financial report.

On motion of Clive Hansen and seconded by James G. Olsen, the annual financial report was accepted.

State Engineer Joseph M. Tracy explained the court case as it related to L. L. Peterson Ditch Co., Oldroyd Ditch Co., Melburn Irrigation Co.. Stating that they could not be assest as a part of the Sanpitch Water Users Association.

Motion was made by Reuel E. Christensen, that we keep in mind the objective of our organization, that of distribution of the waters of the Sanpitch river, and that the organization continue as we are now organized. It was seconded and passed.

Blain Draper was recommended to the State Engineer to be appointed as water commissioner on the Sanpitch river. (passed)

The present executive committee was re-elected, to serve another year. Motion was made by Erwin Morely, seconded, and passed.

Motion by Clive Hansen for the State Engineer to pay committee expense without itemization. (passed)
