THE ANNUAL MEETING OF THE SPANISH FORK RIVER DISTRIBUTION SYSTEM, HELD IN THE STRAWBERRY WATER USER'S CONFERENCE ROOM AT PAYSON, UTAH

Donald Norseth called the meeting to order and gave a brief water report. He stated that most areas of the state have normal or above normal amounts of precipitation to date. Some areas in the southern part of the state are rapidly approaching normal precipitation. Last year some areas used the small amounts of water available for stock purposes.

The minutes of the last Annual Meeting held March 9, 1977 were read by Secretary August Swenson & upon a motion by Allen Galt, seconded by Ernest Hanks the minutes were accepted as read. A copy was left with Donald Norseth.

Donald Norseth read and explained the State Engineer's Financial Report. He stated that an assessment had been missent but was now paid and credited to the right account. Snell Swenson made the motion seconded by Reed Christmas that the Financial Report stand accepted as read. The motion carried.

Lynn J. Mendenhall gave the River Commissioner's Report. A copy was furnished to Mr. Norseth at the meeting. Ronald Davis gave the Deputy River Commissioner's Report. Upon a motion by Clair Anderson, seconded by Reed Rindlisbacher the reports were accepted.

The proposed budget for 1978 was read by the Secretary August Swenson and upon a motion by Reed Christmas seconded by Reed Rindlisbacher the proposed budget was accepted as read, a copy was left with Donald Norseth.

John D. Huff reported that members of the River Distribution System wanted to recommend Lynn Mendenhall for River Commissioner and Ronald Davis for Deputy River Commissioner for the 1978 irrigation season.

Mr. Donald Norseth said that he would accept the recommendation & make the appointments.

John D. Huff asked Mr. Norseth if the Spanish Fork River Distribution System had any responsibility in Flood Control on Spanish Fork River? Mr. Donald Norseth said that Flood Control was not the responsibility of individual groups. He agreed to talk to Mr. Walt Draper of the Flood Control and inform him on this matter.

Reed Rindlisbacher said that the Bureau of Reclamation would like to meet with members of the Spanish Fork River Distribution System. Mr. Reed Rindlisbacher will make the arrangements for the meeting.
