#### Financial Report:

The financial report was given by Robert Guy. The report was read and approved. A copy of this report had been sent to all board and Committee members. It was reported there was \$43.00 left in the reserve.

A suggestion was made by Robert Guy that there be a 12¢ per acre assessment made. Motion was made by Jon Wilde that the assessment be made seconded by Alonzo Jarvie. Voted and approved on by all for assessmet. None against it.

#### Commissioner Report

The Commissioer Report was given by Donald Norseth. Commissioner LaRay Sadlier had had an accident on his way to Rock Springs, Wyo. to a Commissioners school and was unable to be in attendance at this meeting.

A discussion on a divider in the Burnt Fork creek was brought up. It was decided that the cost would be to high to put in a structure that would stand spring runoff.

There was also a report given on all ditches and canals. When the water was turned on and the date it was shut off and how it was regulated.

A discussion of the Baldy Spring ditch was brought up because water had been left on all through the winter.

#### Water Report:

The Water report was given by Don Norseth. Moisture this year was some less in high mountains. More snow in lower vally"s this year. Mr. Norseth reported Henrey's Fork 132 of normal and Spirit Lake 130 above normal.

#### Discussion

There was a discussion on Island Lake. The Engineer Dep. was to make a study of the lake and including in study, the flow from the lake. At which time the study was completed the Interstate Canal Co. was to put a measuring device at outlet of lake.

It was also agreed that the fill on Island Lake would be checked when it was necessary to start regulation of water.
