

A water meeting was held February 7, 1962 for all water users of the Burnt Fork - Birch Creek Distribution System to discuss the financial report of 1961 and to decide on a water commissioner for the coming year, 1962.

The meeting was called to order at 2:15 P.M. by Charles Meeks, Chairman of the Board. Minutes of the last meeting, held March 7, 1961, were then read by the secretary, Laray Sadlier and were approved by all present.

Frank Reese then gave the Financial Report of the year 1961 and stated that the members of the Utah water users were in the red to the Engineers' Bank Book by \$200. This was discussed further by those present and it was found that the Utah water users had overpaid the Water Commissioner \$193.00 for the year 1961 which should have been paid by Wyoming. Utah paid \$433.00 to the Commissioner and of this amount only 30% or \$240.00 should have been paid by Utah. Wyoming should have paid 70% or \$560.00 out of the \$800.00 total appropriated for the Commissioner for the year 1961. It was voted on to let the Financial Report remain the same until the difference in money is cleared up with the state of Wyoming. After the Financial Report is cleared up, Utah will have \$102.94 remaining to their account.

1962 users
The payment to the Water Commissioner was discussed and Utah has agreed to make payment of \$240.00, Utah's share, to the Water Commissioner as soon as possible after the water assessments are in to the State Engineers office.

Clarence Erickson, Distribution Engineer, gave the Water Commissioner's report on the amount of acre feet each ditch received during the year 1961 and said a copy of the amount of acre feet received would be forwarded to each committee member in the near future.

Everyone present at the meeting was in favor of retaining Lyle Anderson as water commissioner for the year 1962 if he would accept the job. The Committee will meet with him in the near future to see if he will accept the water commissioner position for 1962.

Committee
Those present at the meeting voted to retain the same Committee for 1962 as were in office in 1961, with Charles meeks, Chairman; Laray Sadlier, Secretary; Bob Gamble, member; and Ronald Smith, member.
