Meeting called by George Waterman, Chairman, for the purpose of considering the resignation of David Rowley, Price River Water Commissioner. Members present were:

Mr. David Rowley tendered his resignation effective April 10, 1972, because of health reasons. He had previously called the State Engineer's Office and informed Mr. Bene, Deputy State Engineer, of his intention to resign and had also called Mr. William Marsing of Price, Utah.


After considerable discussion, it was concluded that Mr. Rowley's resignation be accepted and that, after all, his health and welfare were to be his first considerations. Dave has done a fine job, and if he finds that at a later date he wishes to come back, his health permitting, the job will be made available to him.

Mr. Rowley recommended that Fred Noyes, watermaster on Carbon Canal, be contacted to see if he wouldn't take the job. After much discussion, it was concluded that Carbon Canal could not release Mr. Noyes for the job in light of the poor water prospects for the coming season.

Mr. Rowley suggested that Mr. Sam Fazzio be contacted since he had worked with Mr. Rowley at different times. Mr. Marsing, Mr. Waterman, and Mr. Bene journeyed to Spring Glen and had a talk with Mr. Fazzio. Mr. Fazzio agreed to take the river commissioner's job for the remainder of the irrigation season providing Mr. Rowley would help him with the written reports. Mr. Rowley had agreed to do this before we left for the Fazzio Ranch at Spring Glen.

Mr. Bene, Deputy State Engineer, was instructed to inform the State Engineer of the action taken and that David Rowley be released from his employment effective April 10, 1972, and that Sam Fazzio be duly appointed for the summer.
