

Price River Water Users' Annual Meeting

Called by the State Engineer February 7, 1973, at 11:00 a.m., Little Courtroom, Carbon County Courthouse, Price, Utah.

Meeting called to order by John Bene, Deputy State Engineer, and then turned over to Chairman George W. Waterman. Mr. Waterman had John Bene read the minutes of the last annual meeting.

A motion was made by Carlyle Pace that the minutes be accepted as read. Motion seconded by Lyle Bryner. Motion carried.

Mr. Bene read the minutes of special meeting called by Chairman Waterman for the purpose of considering the resignation of Dave Rowley, Price River Commissioner. Date of meeting: April 15, 1972, at 4:00 p.m. Dave Rowley had tendered his resignation to the State Engineer, Hubert Lambert, in writing on April 10, 1972.

Members present at the special meeting were George Waterman, Carlyle Pace, David Rowley, Bill Marsing, and John Bene, Deputy State Engineer.

Sam Fazzio was contacted and hired for the remainder of the season or until such time as Dave Rowley could come back. See special meeting.

Ken McKinney, Price Area Engineer, gave the financial report.

Frank Kochevar made a motion that the financial report be accepted. Motion seconded by Twisty Rich. Motion carried.

Dave Rowley read highlights from his annual report. After some discussion a motion was made by Carlyle Pace that the river commissioner's report be accepted. Motion was seconded by Dick Borrell. Motion carried.

Next order of business was setting of the budget and assessment to be made for 1973. After considerable discussion, a motion was made by Fred Reynolds that the budget be set the same as last season, \$4545.00, and the assessment be made for ~~\$4045.00~~ and that \$500.00 be taken from the bank reserve. Motion seconded by Albert Thayne. Motion carried.

Dave Rowley's application for river commissioner's position was read and accepted by the water users.

Dave Rowley is to be paid \$1000.00/year - 12 months - at the rate of \$83.33/month plus automobile expenses at the same rate as the year before. Selma Rowley is to be paid \$1000.00/year for keeping records and helping on report at the rate of \$83.33/month for a period of 12 months.




Dear Sir:
