At the meeting, the water users will need to either recommend that the State Engineer re-appoint you or the water users will need to follow the process outlined in the administrative rules (R655-15-7(2)) to select another person to be appointed by the State Engineer to serve as deputy water commissioner.

You are probably aware that Administrative Rules provide that "a Commissioner's term of appointment will terminate at the Annual Meeting prior to the Commissioner's 75th birthday" [R655-15-7(4)(d)]. However, the rule also states that "the State Engineer may extend a person's appointment as water commissioner to one additional term beyond the person's 75th birthday or until age 79 (whichever comes first)" [R655-15-7(4)(e)].
