RE: BURNT FORK DISTRIBUTION

Enclosed is a copy of letter from Earl Hanks concerning storage of the waters of Burnt Fork. He states that Hoop Lake has been shut off from storage while Island Lake has been allowed to continue.

If the natural flow rights have been satisfied, the Hoop Lake should be allowed to store the same as Island Lake. If there is no storage water available, then Island Lake must also be shut off from storage.

Will you go up and check this out and remedy the situation. If you run into a problem wherein Island Lake cannot be regulated, will you set it out for me so that we can get together with Earl and see what we can do about it.
