Last year the State Engineer sent notices to you dated June 22, 1988 and July 13, 1988, concerning your assessment account which has been delinquent since 1986. The total amount due, including the 1989 assessment, is \$148.93. Inasmuch as you did not respond to the notices, the State Engineer in accordance with Section 73-5-1, Utah Code Annotated, 1953, will initiate legal action to collect your unpaid water assessment. The action will also demand that you pay the legal costs required to prosecute and collect the unpaid assessment.

If you are willing to meet with representatives of the State Engineer and myself to work out a reasonable payment plan for this debt, I will be happy to accommodate you. Otherwise, legal action will be commenced shortly.
