Enclosed is original Assignment executed by Mosby Irrigation Company, assigning App. No. 45-525 (A27125) to Uintah Water Conservancy District, Trustee, in accordance with the letter dated February 3, 1986, from Hugh W. Colton, attorney, as approved by David W. Rasmussen, Manager, and as qualified by my letter to your District dated August 7, 1986. Pursuant to the foregoing, Mosby Irrigation Company filed Segregation App. No. 45-5284 (A27125a) to segregate 921 AF from App. No. 45-525 (A27125) and filed Change App. No. 45-5284 (a14387) to change the 921 AF to Blanchett Park Reservoir. Both Segregation App. No. 45-5284 (A27125a) and Change App. No. 45-52824 (a14387) were approved by the State Engineer on January 27, 1989. Accordingly, there remains 279 AF in App. No. 45-525 (A27125), which is assigned to your District by the enclosed Assignment.




