Re: Water Use Report for East Jordan Irrigation Company

Dear State Engineer:

This Water Use Report for East Jordan Irrigation Company ("East Jordan") is submitted in response to your request dated March 29, 2006 and to a subsequent letter which extended the deadline to October 17, 2007. As explained in your letter, the request was made pursuant to Section 73-5-8 of the Utah Code. The letter requested East Jordan to "identify all acreages to which water for irrigation is physically being delivered from your canal."

As per the request and a subsequent meeting with the State Engineer and canal company representatives, the report is not submitted for purposes of any formal or informal adjudication of East Jordan's water rights. The information presented here only shows a portion of the water used under East Jordan's water rights. Rather, the information is to be used for water management for the mutual benefit of the company, its shareholders and the State Engineer.


In compliance with the letter and Section 73-5-8, East Jordan reports the area on which water was used for irrigation from the East Jordan Canal. In accordance with state engineer practice, the areas are identified by 40-acre quarter-quarter sections with the corresponding number of irrigated acres indicated. The areas are described in the attached three-page Place of Use and Acres table.

Because the information includes only acreages receiving water from the canal, the acreages identified do not include lands outside of those boundaries, such as areas using water under East Jordan water rights by change application. This includes water being delivered through the canal for shares owned by Salt Lake City approved for municipal use by change applications.
