**Beryl/Enterprise Water Distribution System  
Minutes for the 2015 Annual Meeting on February 17, 2015  
Escalante Valley Community Center, Beryl Junction, Utah**

The Meeting was convened at 1:00 PM by Mike Brown, Chairman.

The minutes of the 2014 Annual Meeting were reviewed. A Motion was made to accept the 2014 minutes as reviewed by Ladel Laub and it was seconded by Brad Bowler. The Motion Passed.

The 2014 Annual water Commissioner's Report was presented by Todd Terry. Members that were present were given a copy pf the report and it was discussed. Nyal Bosshardt made a motion to approve the commissioner's report and Wayne Facett Seconded the motion. The motion passed.

Jared Manning, from the State Division of Water Rights, reported on some new laws that were possibly going to involve the water users. House Bill 258 was discussed, which involved liability insurance for the water commissioner. He discussed the option of being able to use the states liability insurance which would be the most cost effective avenue for the water users.

Mike Silva reported on the snow pack situation for the area. It was below normal at that time.

Mike Silva presented the 2014 Financial Report. Ladel Laub made a motion to approve the financial report and Brad Bowler seconded. The motion passed.

The Delinquent water assessment were reviewed and there seemed to be no concerns. There was discussion on the 2015 budget and there were some minor changes that were made. The motion to accept the changes was made by Ladel Laub and seconded by Wayne Facett.

The 2015 Annual Water Users Assessment was discussed and was the motion to leave it the same at \$19000.00 was made by Brad Bowler and seconded by Howard Bracken. The motion passed.

Mike Brown stated that 3 positions of the board were up for re-election: Craig Laub, David Bosshardt and Brad Bowler. A motion was made by Nyal Bosshardt to suspend the rules and reelect the current board members. The motion was seconded by Wayne Facett. The motion passed.

The meeting adjourned at 2:00 PM

## ***2015 Commissioner Report***

1. Mapping crop types and making changes to the system map was number one on my agenda this year.
2. The map imagery was not updated this year therefore I relied on the user's information and my observations when changing the map. If you notice something isn't quite right on the map from this year or anytime, please let me know.
3. For the Pinto surface water I removed the tags from the diversions in April and put them back on in November.
4. Due to a very dry year Newcastle reservoir filled to within 15 feet of top. Water users in Newcastle were limited to 21% of their surface water use. Enterprise reservoir upper and lower did not receive much runoff and was estimated to be at 25% capacity. Because Enterprise was at 25% stock holders were allowed only 25% of their normal water allotment.
5. The ground water management plan depletion report is sometimes hard to understand. That being said, I think it's important to understand that the depletion isn't based solely on how many gallons of water you pump onto a field. It's based on crop consumption, evaporation and other factors. For example if you walk into a field of corn compared to a field of alfalfa you will feel the effects of the corn holding moisture or humidity on the field. However, if you would like more details on this subject you will have to call someone else :)
6. To restate another concern I have with the ground water management plan. When we established the base line it was based on the current water rights being used for irrigation. However, there seems to be a new water right or two that are introduced to the system each year that wasn't there before. What I'm trying to say is the system baseline is good but not perfect.
7. Do you remember a couple of years ago when I was so excited to get a plotter for printing maps and what-not, well, it's turned out to be expensive to keep it operational. For this reason I've decided to forgo another set of ink cartridges. From now on if we need a map printed we'll have to go to the Cedar office.

## Beryl Enterprise: Distribution Engineers Report

### Snowpack:

Last Year much of what was not available as snowpack, seemed to be made up by significant rain in May and early June 2015. This wet spring spared many systems from anticipated severe drought conditions, along with occasional rains. This was the fourth dry year in a row, but it's now behind us.

Seems the long anticipated El Nino is manifesting this winter in making Snowpack, currently hovering better than 140%. Accumulated snows by the end of December 2015 had as much snow water content as the entire previous winter, so we can only do better than last year from this point on for our snowpack. Regular storms are happening at this writing.

Continued snow through the rest of the season will keep us in water this year. This is a good problem to have, but runoff and melt rate will be important to watch. We have a lot of snow on the ground at low elevations. I am expecting conditions similar to the 2011 runoff year depending on the melt rate, but the recent springtime tendency has been early melt and rain on snow events in the spring. As of Feb 9<sup>th</sup> the Snowpack numbers for Southwestern Utah, and this area are at 147%. All diversions should be ready for high runoff conditions. There should be no problem with filling reservoirs this year depending on snowmelt.

### Assessment and Measurement:

Please review the Maps and check to insure that billing acres is correct for what acreage showing on your part of the spreadsheet showing the corresponding Water Rights listing. This creates the basis of prorated billing for your account.

### Water Commissioners are Now State Employees:

House Bill 258 has clarified that water commissioners are state employees of the division of water rights. Several operational changes are necessary to comply with the law. Jared will discuss more of this, as some items will also influence the budgeting process.



## **Escalante Valley**

### **Beryl-Enterprise Area**







Figure 44. Location of wells in the Beryl-Enterprise area in which the water level was measured during March 2015.

The Beryl-Enterprise area covers about 800 square miles at the southern end of Escalante Valley, southeast of the Wah Wah Mountains in Iron County, and a small area in Washington County in the vicinity of the community of Enterprise (fig. 44). Groundwater occurs in unconsolidated basin-fill deposits in the valley.

Total estimated withdrawal of water from wells in the Beryl-Enterprise area in 2014 was about 103,000 acre-feet, which is 10,000 acre-feet more than in 2013 and 15,000 acre-feet more than the average annual withdrawal for 2004–2013 (tables 2 and 3).

The location of wells in the Beryl-Enterprise area in which the water level was measured during March 2015 is shown in figure 44. The relation of the water level in selected observation wells to cumulative departure from average annual precipitation at Enterprise, to annual withdrawal from wells, and to concentration of dissolved solids in water from well (C-34-16)28dcc-3 is shown in figure 45.

Precipitation at Enterprise in 2014 was about 14.6 inches, which is about 0.6 inch more than the average annual precipitation for 1955–2014 and about 2.8 inches more than in 2013.

Water levels declined from March 2014 to March 2015 in most of the wells measured in the Beryl-Enterprise area. Water levels throughout most of the area have declined steadily since 1950 and have shown little or no recovery, even during periods of greater-than-average precipitation. For example, water-level measurements in well (C-36-16)29daa-1, about 5 miles northeast of Enterprise, have shown a decline of nearly 139 feet from March 1948 to March 2015 (fig. 45). Declines such as this are a result of continued large withdrawals for irrigation beginning in about 1950.




Figure 46. Water-level change in the Beryl-Enterprise area from March 1985 to March 2015.

Water levels from March 1985 to March 2015 declined in all of the Beryl-Enterprise area for which data are available (fig. 46). The greatest decline, more than 86 feet, occurred in a well about 3 miles north-northeast of Enterprise. Declines are probably the result of continued large withdrawals for irrigation.

The concentration of dissolved solids in water samples collected from well (C-34-16)28dcc-3, located 6 miles south-southeast of Beryl, is shown in figure 45. The concentration of dissolved solids in the water sample collected in August 2014 was 582 mg/L, a decrease of greater than 100 mg/L from the 2013 value.
