
C. A. GRANT, Clerk of this Court, having filed his petition in this Court, and from which it appears:

1. That, Frank Knight, of Kamas, Summit County, State of Utah, is a successor in interest to Ellen Gines and James A. Knight, parties to the above entitled cause, and is the owner of certain water rights awarded therein.
2. That, the decree in the above entitled cause provides that the parties and/<sup>their</sup> successors in interest pay to the Clerk of this Court a ratio of the expenses of administration and distribution of the Provo River and its tributaries, the same to be paid within ten days after notice of the amount thereof.
3. That, said Frank Knight, has failed to pay said assessments, and now refuses to pay any part or portion thereof.
4. That, the amount of assessments now due from said Frank Knight is \$208.76.
5. And that, said Frank Knight be ordered to appear before this court at such time as the court may appoint, and show cause why a judgement for \$208.76 together with costs and interest should not be entered.

It is now therefore ORDERED that, the above named Frank Knight show cause before the above entitled court at its court room in the City and County Building at Provo City, Utah County, Utah, on the 13<sup>th</sup> day of Feb. A.D., 1943, and at 10:00 o'clock a.m. of said date, or as soon thereafter as counsel can be heard,

why judgement should not be entered for \$208.76 together with costs and interest according to the said petition.

IT IS FURTHER ORDERED, that a copy of this order be served upon said Frank Knight.
